Ministerial Modification for Designated Executives and Classes of Designated Executives

I, Travis Toews, President of Treasury Board and Minister of Finance, pursuant to section 8 of the Salary Restraint Regulation, do hereby modify section 5(1) of the Regulation with respect to the employment of the classes of designated executive positions listed in column 1 of the Appendix at Alberta Investment Management Corporation for the number of employees listed in column 2 to allow an increase to the base salaries not to exceed the percentage increase amount specified in column 3 in entirety. The permitted increases to base salary may be effective on or after January 1, 2022.
